#### ACTIVATION

The 914<sup>th</sup> Ordnance Heavy Automotive Maintenance Company was activated as the 914<sup>th</sup> Ordnance Heavy Maintenance Company (Q), 6 April 19 at Camp Polk, Louisiana under T/O 10-27; assigned to Third Army, attached to 24<sup>th</sup> Ordnance Battalion and III Armored Corps.

The original cadre consisted of one officer, 1<sup>st</sup> Lt. Chauncey M. Sanner; Commanding, and twelve enlisted men, of the 77<sup>th</sup> Ordnance Battalion, namely;

Two hundred eighty six fillers (recruits) arrived 11, April 1943 from Benjamin Harrison, Indiana, and Fort Thomas, Kentucky, to complete the enlisted strength of the organization. These men well represented the Fifth Service Command, coming from the States of Ohio, Indiana and Kentucky.

# BASIC TRAINING

Although handicapped to some degree by the lack of Officer personnel, basic training was started immediately. The fillers were the rawest of recruits having no previous military training, being signed direct after processing at the reception centers.

At this time the rapid expansion of the Armed Forces made it necessary to interrupt the training program to construct a tent camp it was necessary to vacate permanent billets. This, too, served as training aid in that it gave the enlisted men a sample of Army Life under field conditions early in their Army Careers. The tent camp was completed 27, April 1943 and basic training resumed.

The enlisted men, although not yet oriented to the Army, did an excellent job of constructing the Tent City which, when completed, made them comfortable homes. In addition an assembly tent was erected to serve as a class room and day room which added to the comfort of the enlisted men. The later proved to be a great asset to them as it provided a more rugged life by keeping them in the out of doors and teaching field sanitation. As the majority of the men were of "teen" age it was not difficult for them to adjust themselves to this type of life.

The arrival of the following officer personnel approximately 1 May 1943 greatly relieved the strain of recruit training from the original cadre:

With the exception of 2nd Lt. Thomas L. Tucker and  $2^{Nd}$  Lt. John R. Halisky the officers were assigned direct from Officer Candidate School with these basis subject fresh in their minds and thus were of great assistance thru basic period.

During the basic period the following additions in enlisted personnel were made:

Staff Sergeant Luther E. Burnett assigned from Post Ordnance Detachment, Fort Sam Houston, Texas.

75 EM of 527<sup>th</sup> Ordnance Company (HM) (TK) attached for Basic Training.

20 Privates First Class assigned from David Rankin, Jr. School Mechanical Trades, St. Louis, Missouri.

Sergeant William E. Hearn assigned from 804<sup>th</sup> MP Battalion (ZI) Mobile Force Special, MDV. Washington, D.C.

Staff Sergeant Harmon F. Canches assigned from Supply and Serv Detachment (ORD), Fort Sam Houston, Texas.

3 Privates First Class assigned from Mt. Rainier Ordnance School, Mt. Rainier, Washington.

With the above additions the enlisted strength of the organization for basic training was 399.

During the basic period there was no technical training due to lack of facilities to accommodate such a large number of men. Basic training was completed and Individual Training Period Test taken 28, July 1943 with a grade of very satisfactory.

The 914<sup>th</sup> Ordnance Heavy Maintenance Company (Q) was re-designated as the 914<sup>th</sup> Ordnance Heavy Automotive Maintenance Company and reorganized under T/O and E 9-197, dated 2 April 1943. Effective date of re-designation and re-organization 1, June 1943.

For the splendid effort put forth during basic training the unit was rewarded with a 3 day trip to Lake Charles, Louisiana for rest and recuperation, after which the much talked of furloughs were begun.

#### TECHNICAL TRAINING

During Technical Training Period it was found the a majority of the enlisted men, being recently out of school, lacked the technical skill and practical experience necessary for an Ordnance Heavy Automotive Maintenance Company. It was therefore, necessary to send approximately 50% of the personnel to Ordnance Technical Schools to gain the technical knowledge required. A small shop was set up for the remaining men for the purpose of acquainting them with the tools and equipment of an Ordnance Heavy Automotive Maintenance Company. In connection with this training several Salvaged vehicles were acquired and dismantled.

During the Technical Training Period the men were making good progress, but before the Technical Training Period was completed the unit was ordered to participate in the Louisiana Maneuvers. As the unit had not received its authorized vehicles, and with a large percentage of the company attending Ordnance Technical Schools, it was a difficult task to prepare for the undertaking in the time allotted (3 days). Many substitutions of vehicles and equipment were made. An incomplete stock of automotive spare parts were hastily acquired. Preparations were finished and the unit departed for Louisiana Maneuver area, vicinity of DeRidder , Louisiana 5, September 1943.

Due to the change to T/O 9-197 from T/O 10-27 the unit was over-strength and was therefore necessary to transfer enlisted men to other organizations. No men were transferred until basic training was completed.

# MANEUVERS

Upon Arrival in the maneuver area the organization was attached to the 590<sup>th</sup> Ordnance Battalion. Having arrived in the maneuver area early, the first week was devoted to making improvements in the mounting of equipment to facilities work in the field. The active maneuvers commenced 13, September 1943.

With the exception of the Commanding Officer and the first Sergeant this was a new experience.

Shortage of personnel and lack of experience, making long hours of work necessary, together with inclement weather made first stage of maneuvers a little discouraging.

The loss of Master Sergeant Joe E. Sigrist to the Hospital 17, September 1943, later transferred to Detachment of Patients, Station Hospital, Camp Polk, La. 16, October 1943, seriously handicapped the organization as there was no one immediately available possessing his technical knowledge and ability.

However, the return of personnel from Ordnance Technical Schools and experience gained in the field made the latter stages of maneuvers more successful.

1<sup>st</sup> Lt. John C. O'Donnell, Jr. was assigned and joined 27, October 1943 from 994<sup>th</sup> Ordnance Heavy Automotive Maintenance Company, assuming duties of Shop Officer; vice 1<sup>st</sup> Lt. Thomas L. Tucker who was at that time awaiting transfer to the Army Air Corps. WOJG Fordyce E. Morgan was assigned and joined 16, November 1943 from 3504<sup>th</sup> Ordnance Medium automotive Maintenance Company, assuming duties of Armament Machinist.

On 20, November 1943 1<sup>st</sup> Lt. Thomas L. Tucker was assigned and departed to Army Air Force Classification Center, San Antonio, Texas.

At the conclusion of maneuvers the Company was doing an excellent job of maintenance. However it was felt that a few older and experienced technicians were necessary to effect maximum efficiency. Therefore arrangements were made to transfer thirty of the lesser skilled technicians to two adjoining Ordnance Units in exchange for a like number of more experienced technicians. Twenty enlisted men were transferred to the 3527th Ordnance Medium Automotive Maintenance Company and ten enlisted men were transferred to the 902nd Ordnance Heavy Automotive Maintenance Company.

Captain Chauncey M. Sanner, then commanding, was relieved from assignment with this organization and was assigned to the 158<sup>th</sup> Ordnance Battalion; 1<sup>st</sup> Lt. John C O'Donnell, Jr. the Shop Officer assumed command 17, November 1943.

Upon the completion of the maneuver period, 20 November 1943, the unit departed vicinity for De Ridder, Louisiana en-route to Camp Bowie, Texas,

The first day's journey brought the unit to Rusk, Texas. This Hamlet was not often frequented by Military Personnel and a GI was a welcome sight. The true Texas Hospitality was displayed when the Chamber of Commerce made arrangements for the unit to sleep in the High School Gymnasium and arranged a party and dance for the entertainment of the soldiers. The personnel were very appreciative of this display of Southern Hospitality. The second night the unit bivouacked in the park at Gatesville, Texas. Third day after leaving the maneuver area, 22, November 1943, the unit arrived at Camp Bowie, Texas.

# UNIT TRAINING PERIOD

Upon arrival at Camp Bowie, Texas, the organization was attached to the 332<sup>nd</sup> Ordnance Battalion and under supervision of the 7<sup>th</sup> Headquarters Special Troops, Third Army. Now, for the first time since activation, the EM was assigned to barracks. The men took great pride in beautifying the area and keeping things tidy as barracks had always been a dream not realized. There were sufficient buildings to permit a large day room, which provided additional comfort to the enlisted men.

At this time orientation was being encouraged to acquaint the personnel with the world situation. A section of the day room was used as the orientation center, displaying maps, pictures, clippings etc. For this orientation effort the unit was awarded a Certificate of Proficiency for the Best Orientation Center under the 7<sup>th</sup> Headquarters Special Troops, Third Army.

A large maintenance shop was operated performing a large share of the maintenance for the post. The mechanical experience gained on maneuvers enabled the organization to operate the maintenance shop most efficiently, with excellent results. A great deal of practical experience was gained from the operation of this shop. During this period 2<sup>nd</sup> Lt. John R. Halisky and four enlisted men Tec 5 Walter B. Douglas, Tec 5 William T. Ely, Tec 5 Carl H. Larson and Tec 5 Edward C. Squires were placed on Detached Service with the 2<sup>nd</sup> Cavalry Division, Fort Clark, Texas for the purpose of inspecting and repairing all weapons. They were highly commended by Major Ronnie White 2<sup>nd</sup> Cavalry Division, for their efficient work.

With Christmas approaching, and with most or the personnel not being able to go home, every attention was turned to making Christmas as pleasant as possible. A Delicious Turkey Dinner with all the trimmings was served in the two main mess hall appropriately decorated for the Christmas Season. Printed menus with the complete roster of the company were presented to the men as a remembrance. Wives and friends visiting the members of the organization for the holidays, were invited and attended the dinner giving a more home like atmosphere.

While at Camp Bowie, Texas, the necessary Qualification in Arms, mental conditioning course and combat fighting in villages were completed, the following training tests were taken:

The Unit Training Period Test consisted of a weeks bivouac in the vicinity of Camp Bowie, Texas under simulated war conditions. All the fundamentals of training were practiced and the unit graded accordingly. The unit was set up to do field maintenance, fully camouflaged so as not to be detected from possible air reconnaissance and attack, and accomplished maintenance.

The Air Ground Test consisted of simulated strafing of the convoy by the Air Force, testing discipline during attack; identification of Aircraft; use of identification panels and codes between Air and Ground forces; and camouflage of bivouac area. The bivouac area of this unit was so well camouflaged that it could not be detected from the air. It was necessary for the inspecting officer to land and visit the area and mark it so that it could be located from the air. Even then no sign of vehicles or activity could be seen from the air.

The Physical Fitness Test demonstrated the Stamina of the enlisted men of organization as they took the various physical tests in fine style. The grade of 87.6% was the highest on record at the 7<sup>th</sup> Headquarters Special Troops, Third Army.

Unit was relived of attachment to 332<sup>nd</sup> Ordnance Battalion and attached to 7<sup>th</sup> Headquarters Special Troops, Third Army 20, January 1944.

Unit was relieved of assignment to Third Army and assigned to Fourth Army 26, January 1944.

Company relieved of attachment to 7<sup>th</sup> Headquarters Special Troops Fourth Army and attached to 321<sup>st</sup> Ordnance Battalion 26, January 1944.

2<sup>nd</sup> Lt. Wilfred B. Ostmeyer was assigned from 845<sup>th</sup> Ordnance Depot Company 12, March 1944 and joined this unit 31, March 1944; assumed duties of Supply Officer, Administrative.

2<sup>nd</sup> Lt. Robert R. Estes was transferred to the 709<sup>th</sup> Headquarters and Headquarters Company, Railway grand Division, TC, Transportation Corps unit Training Center, Camp Plauche, Louisiana 26, January 1944.

Unit relieved of attachment to 321<sup>st</sup> Ordnance Battalion and attached to 332<sup>nd</sup> Ordnance Battalion 13, April 1944.

During the voyage much time was devoted to emergency drills and inspections. Movies were available, talent solicited for deck entertainment and games and reading materials were available. With the availability of the above entertainment the enlisted men's time was well spent and with the exception of usual cases of seasickness the voyage was enjoyable.

# UNITED KINGDOM

Land was first sighted 14, May and the 15, May the ship anchored off the bar at the entrance to Liverpool. The unit disembarked 16, May 1944 and immediately boarded a train for Crowe where a reception party was awaiting the unit's arrival with transportation to Doddington Hutted Camp, Cheshire.

While at Liverpool the personnel saw at first hand the ravages of war, thru the sunken ships in the harbor and the bombed buildings in the city.

Upon arrival in England, unit was assigned to the Third United States Army, and later attached to the 316<sup>th</sup> Ordnance Battalion 20, May 1944.

The first weeks in the United Kingdom were spent in physical conditioning and receiving vehicles and equipment. On 27, May 1944 the unit was relieved of attachment to the 316<sup>th</sup> Ordnance Battalion and attached to the XII Corps.

The organization was then assigned the mission of conducting a waterproofing school for the XII Corps, and left Doddington Hutted Camp, Cheshire arriving at Ogbourne St. George, Wiltshire 10, July 1944 for this purpose. The waterproofing school was conducted for one week from 18, July to 22, July 1944, and was attended by 13 officers and 40 enlisted men of the 80<sup>th</sup> Division. The unit was highly commended by Major William McCool, 80<sup>th</sup> Division Ordnance Officer, for the efficient manner in which the school was conducted.

With the completion of the waterproofing school, all time was devoted to mounting of equipment on unit vehicles in preparation for movement to the continent. Previous maneuver experience provided valuable in this respect as the problems of field maintenance were realized and the equipment mounted accordingly. An effort was made to make the unit as mobile as possible and still perform its primary mission. In addition, maintenance work was carried on for units located in the vicinity of Ogbourne St. George.

During the stay in England the organization was called upon to furnish the following officers and EM to assist at various Headquarters and Ordnance Depots.

# FRANCE

The organization embarked at Weymouth, England 7, August 1944 on two LCT's, one LCI and one LST, arriving at Omaha Beach France 8, August 1944. The various groups immediately departed by foot for Transit Area "B", located eight miles inland at St. Germain de Verreville, France, where vehicles and personnel were regrouped. Much of the debris from the action of "D" Day had not been cleared away and this helped considerably to impress upon the men the seriousness of the situation.

The following evening 9, August 1944, unit departed St. Germain de Verreville and arrived at Lucky Ordnance Concentration Area located at Brie Quebec, France.

The unit, now ready to launch upon its primary mission, departed Brie Quebec, France and arrived at bivouac area 1.3 miles southwest of Landean, grid coordinates vY39 85, 12, August 1944. Ordnance maintenance work was started at once, vehicles being drawn from 70<sup>th</sup> Ordnance Group Collecting Point for repair.

Movement was made from bivouac area 1.3 miles southwest of Landean to bivouac area 1.25 miles southwest of Mezieres-sous, grid coordinates 275 510, 17 August 1944. The mission of vehicle maintenance was carried on vehicles coming from using units and 70<sup>th</sup> Ordnance Group Collecting Point. The hard earned lessons of maneuvers proved of great value in performing maintenance in the field.

Two enlisted men, Sergeant Kenneth W. Christie and Technician Fifth Grade William E. Sanders, received commendations for meritorious service from Major John C. Hendrie, commanding officer of the 312<sup>th</sup> Ordnance Battalion 21, august 1944 for prompt action in clearing one of our Army's main supply routes of a wrecked vehicle the night of 18, August 1944. Sergeant Christie, realizing the seriousness of the road block, pulled his load to the side and immediately proceeded to clear the road of the wrecked vehicle, and in a very short time had traffic moving normally.

Continuing on its mission of maintenance of Third United States Army vehicles the unit departed the bivouac area 1.25 miles southwest of Mezieres-sous and arrived in the bivouac area 1 mile northeast of Champrond-en-Gatine, grid coordinates 092 005, 22, August 1944. Road Patrols of wreckers crews and mechanics were established to render necessary service along the highways and keep the supply lines clear of wrecked and stalled vehicles. This was a much-needed service and resulted in expediting many stranded vehicles.

On the trip from Mezieres-sous to Champrond-en-Gatine, the convoy was halted by an accident, which had happened a few minutes previously completely blocking the highway approximately 2 miles northwest off LeMans. A diamond T cargo Truck pulling and Engineer trailer loaded with a Bulldozer, had been crowed off the road and jack-knifed striking two French civilians on bicycles, seriously injuring one and pinning one underneath the rear wheels of the truck. First Aid was immediately administered by Sergeant Jack H. Bowling, this organization, to the injured civilian who was then rushed to a nearby Field Hospital. Meanwhile Sergeant Kenneth W. Christie and Tec 5 William E. Sanders proceeded with the task of raising the truck to permit removal of the second civilian. After the civilian was removed, the wrecker crew proceeded wit the difficult task of clearing the highway of the wrecked vehicle.

The organization was further attached to the 312<sup>th</sup> Ordnance Battalion 25, August 1944.

The unit went on from Champrond-en-Gatine area and set up in a bivouac area <sup>1</sup>/<sub>4</sub> mile north of Mountainville, France, grid coordinates 400 842, 26, August 1944. Maintenance of vehicles and patrolling of highways continued.

The unit then moved to an area 2.50 miles southwest of Fontainbleau coordinates vX 25 87, 4, September 1944. Unit was relieved of attachment to 312<sup>th</sup> Ordnance Battalion and attached to the 79<sup>th</sup> Ordnance Battalion 4, September 1944. No maintenance was accomplished in this area as further movement was to be made immediately. While waiting further movement orders passes were issued to the enlisted men to visit points of Historical Interest in Fontainbleau and vicinity.

On 7, September 1944 unit departed from area of Fontainbleau and arrived a new bivouac area 1.2 miles northwest of Varennes-en-Argonne, grid coordinates U 019 737, 8, September 1944. An overnight stop had been made en-route, 5.5 miles west of Vitry Le Francois, 7, September 1944.

While making a reconnaissance for the new area in the vicinity of Varennes-en-Argonne, France 8, September 1944, two German soldiers were encountered and captured, later turned over to the Military Police at Chalons.

Unit departed area of Varennes-en-Argonne and arrived at new area 6.4 miles northeast of Clermont, France grid coordinates U 125 640, 11, September 1944.

Maintenance work continued at a brisk pace in this locality, as it was located on the main supply artery. Road Patrols were used to full advantage.

On the 22, September 1944 move was made from vicinity of Clermont to bivouac area 1 mile west of Fresnos, grid coordinates vU 44 57. Weather conditions were against maximum efficiency due to much rain and increasing cold weather.

It was determined that billets and a covered work shop would be necessary to attain maximum efficiency of this type organization. Therefore the unit left the bivouac area in the vicinity of Fresnes, grid coordinates vU 38 34 5, October 1944.

All of the shop was now in buildings and not hampered by the weather. A large increase in production was immediately noticed and the unit approached maximum in efficiency. The men were now billeted allowing them more comfort and better rest. A pass program was inaugurated and movies were frequently available, thus helping the morale of all personnel.

An acute need for rebuilt units arose, thus the mission of this organization was changed from general maintenance to unit rebuild, and on 17, November 1944 the unit moved from St. Mihiel to Essey les Nancy, France. Grid coordinates vU 89 12, with shop buildings at St. Max, approximately 2 miles from the C.P. and billets.

From the period of general maintenance work from 14, August 1944 to 16, November 1944 the following job orders were completed:

The organization vigorously launched upon its new mission of unit rebuild. Many changes were necessary in the automotive platoons to make possible a production line each for engines, transmissions and transfer cases. Much had to be accomplished in the way of engine stands and miscellaneous features necessary for efficient operation of the various production lines. In addition to rebuilding units, metal spray was experimented with. One of the results of the experimenting was the building up of badly worn or scored brake drums with metal, and then turning the drums down to proper specifications. Successful results were obtained from this method, with many otherwise unserviceable drums becoming ready for use. Badly worn crankshafts were also successfully built up with metal spray and made serviceable. At this time the above critical items were not immediately available in the supply depots. This metal spray operation gave an excellent performance its mission of unit rebuild, considering the shortage of manpower caused by twenty enlisted men leaving for retraining a infantry riflemen, twenty one enlisted men guarding the Forts Joan De Arc and Driant at Metz, and one officer and five enlisted operating the Salvage and Reclamation Point for 79<sup>th</sup> Ordnance Battalion. On 25, December 1944 this unit experienced its first bombing. Several anti-personnel bombs were dropped about the area but no damage resulted.

During this time, three enlisted men, Tec 4 Francis W. Hearn, Tec 5Walter B. Douglas and Tec 5 Robert W. Sprengel, were placed on temporary duty with the Third United States Army Rest Center in Nancy, France for the purpose of repairing and maintaining the small arms of soldiers brought back for rest. A letter of commendation was received from the Commanding Officer of the Rest Center citing the excellent work of this Small Arms Section.

While located at Essey Les Nancy a basketball court was obtained in Nancy for the use of the personnel. The basketball team played the French team of Nancy four different times and were victorious each time by a considerable margin.

Once again it became necessary to move to keep up with our advancing Third United States Army. On 31, January 1945 this unit moved from Essey Les Nancy to Longwy, France, grid coordinates vP 58 05. The need for general maintenance became acute and the mission for this organization changed from unit rebuild to general maintenance.

The unit was relieved of attachment to the 79<sup>th</sup> Ordnance Battalion and attached to the 66<sup>th</sup> Ordnance Battalion 10, March 1945.

On 11, March 1945, this unit, in view of its excellent record, was selected to perform a mission called Operation "Q". The mission of Operation "Q" was to furnish mechanically serviceable trucks, cargo, LWB, 2.5 ton, 6x6 to replace all like vehicles in Third United States Army Quartermaster Trucking Companies in the shortest possible time.

An initial pool of seventy-five vehicles was given this unit for complete rehabilitation. Fifty of these were to be ready for exchange with the Quartermaster Trucking Company at the earliest possible moment. However when these Fifty trucks were ready to be exchanged there was an urgent demand for ammunition to be transported. As no other trucks were available, the fifty trucks scheduled for the Quartermaster Trucking Company were detailed to haul ammunition, and have remained in service for this project. Twenty-five men of this organization served as drivers for approximately one week and were the replaced by men from other organizations.

On 14, March 1945 1<sup>st</sup> Lt. John E. Weflen was lost to the 193<sup>rd</sup> General Hospital.

On 25, March 1945 unit departed Longwy, France and arrived at Bouzonville, France, grid coordinates wQ 13 77 where Operation "Q" continued. In addition, a road patrol and tire patrol for the maintenance of the stranded vehicles was operated.

While at Longwy and Bouzonville three day passes to Paris were issued to the following personnel and enjoyed thoroughly by them:

This organization also participated in the Campaign of Germany and has been authorized to wear the Bronze Service Star for the applicable Campaign per letter Headquarters European Theater of Operations United states Army file OpGA 200.6 dated 24 December 1944.

This organization was awarded the Meritorious Service Unit Placard for its excellent record during the period 15 November 1944 to 14 February 1945 per section II, General Orders 78, Headquarters Third United States Army, dated 12 April 1945.

#### SUGGESTIONS

It has been our experience in this theater that spare parts for major items of organizational equipment are critical and in most cases not available. It has frequently been found more expeditious to exchange the complete major item of the equipment than to obtain the necessary part.

It is therefore recommended by this organization that spare parts for major items of organizational equipment be included with initial issue of such major items. Below is a suggested list of critical spare parts to be included with initial issue of major items of organizational equipment:

2 plugs, 3 phase for Generator A.C. Portable Gas Engine Driven, 5000 Watts, 120V, 60 Cycle #17-G-2045.

3 Finishing Stones and 3 Roughing Stones for Valve Resurfacer Electric 5/16" to 5/8", Capacity 110 volt, Universal Current # 40-V-505

As a further suggestion the following additions to T/O and E 9-197, dated 27 May 1944 are submitted:

3 semi-trailers, 6 ton, 2 wheel, combination animal cargo, for use as Machine Shops and Carburation and Electrical Shop.

2 Tractors, 4-5 ton, 4x4, to make unit more mobile.

Tentage – More tentage is needed for shop operation in the field during bad weather. Also tentage is needed for GP, Shop Office and Motor Supply Office.

Thru the experience of the various missions performed by this organization it is our conclusion that no perfect T/O and E can be published. In our estimation T/O and E 9-197 dated 27 May 1944, with the suggestions above, is as near perfect for the organization of this type as can be devised due to the flexibility of missions, providing higher Headquarters will authorize the acquiring of additional equipment as necessary.

#### GENERAL

This organization at the time of arrival on the continent, was completely mobile, and able to efficiently perform general maintenance by replacement units. The fact the unit was mobile proved advantageous during the swift advance across France. As the fronts became more static the missions of this organization were frequently changed necessitating acquiring of new equipment and different type of parts. Due to the frequent changes of mission it has been necessary to retain additional equipment and parts, thereby making the organization less mobile, but by the same token more efficient.

Many difficulties were encountered in the transformation from a mobile maintenance unit to conform with requirements of various missions. In the transformation process considerable time was lost due to acquiring necessary parts and equipment and making new equipment. By efficiently overcoming these difficulties the unit has achieved versatility in maintenance. This unit has proven itself capable of performing any echelon of maintenance up to including fifth echelon of maintenance.



#### ANNEX TO COMPANY HISTORY

While at Hattersheim, Germany a volleyball and softball team were organized inaugurating the summer sport activities. Both teams were entered in the 66<sup>th</sup> Ordnance Battalion League and performed in an excellent manner.

On 10 May 1945 it was once more necessary for the unit to move. Unit departed Hattersheim, Germany and arrived at Furth, Germany, grid coordinates wO 36 00. General Maintenance work was also performed in the area.

With the was in Europe over, the personnel were able to travel around somewhat and see parts of Germany not previously covered. One of the concentration camps operated by the Nazi was visited by some of the members, establishing the truth of the treatment given by Germany to prisoners.

The athletic program continued with greater emphasis being placed on intra-company games. The softball games ended with the first platoon, lead by pitcher "Chuck" Prakel, winning four games and losing none while the second and third platoons both won one game and lost three. It was too much Prakel for them.

Secor's "Redeployment Tavern" was operated every night that beer was available, with Coca Cola also being served. This was an added attraction and compensated for the "no pass" policy in Germany.

1<sup>st</sup> Lt. John T. Lampila, shop office, was awarded the Bronze Star Medal for Meritorious Service by Lt. Colonel Grubbs, commanding officer, 66<sup>th</sup> Ordnance Battalion. The award was presented 21 May 1945 at Furth, Germany.

2<sup>nd</sup> Lt. Frank C. Holle joined the organization 7 May 1945 from the 17<sup>th</sup> Reinforcement Depot.

With the war in Germany completed the unit was directed to move back to France, and departed Germany 2 June 1945.

While in Germany, Tec 4 Albert T. Koeppen, Tec 4 George Solo and Tec 5 Carl H. Larson were placed on TD with 70<sup>th</sup> Ordnance Group for the purpose of inspecting ordnance material. Tec 3 Gustave R Schaser was placed on TD with Third U.S. Army for liason work coordinating machine-shop work in Luxembourg city for Third U.S. Army.

Enroute to Depot 0-644, Vincennes, Paris, France from Furth, Germany, overnight stops were made at Kaiserslautern, Germany on 1 June 1945, and at Verdun, France on 2 June 1945. The organization arrived at Depot 0-644, Vincennes, Paris, France 3 June 1945.

This organization was relieved of attachement to 66<sup>th</sup> Ordnance Battalion and 70<sup>th</sup> Ordnance group, relieved of assignment at Third U.S. Army and assigned to 12<sup>th</sup> U.S. Army Group per 12<sup>th</sup> U.S. Army Group Troops Assignment number 137, effective 28 May 1945. Relieved of assignment to 12<sup>th</sup> U.S. Army Group and assigned to Seine Section per Troop Assignment number 101 Headquarters ETOUSA effective 2 June 1945. Attached to 604<sup>th</sup> Ordnance BAM battalion, per SO 121, Headquarters Depot 0-644 effective 2 June 1945.

The big question in the mind of everyone now was whether or not the Company would stay in Europe as Army of Occupation or go to the Pacific theater either direct or indirect through the States.

The question was answered on 15 June 1945 when the unit was alerted for Direct Shipment to the Pacific Theater. This was a disappointment for everyone but was taken in good stride. Hope was in everyone's mind that orders would be changed, as each one was homesick for their loved ones.

The organization now began to transfer out men over thirty nine years of age and with more than eighty five points, as well as men not physically qualified for further duty in active theater.

On 19 June 1945 unit relieved of attachment with 604<sup>th</sup> Ordnance BAM Battalion and attached to Camp PA, Departed Depot 0-644, Vincennes, Paris, France and arrived at Camp PA, Villocoublay, France 19 June 1945. While at this location the organization crated and waterproofed all of it's equipment for shipment to the Pacific. Replacements were received and some men transferred out.

Captain John C. O'Donnell, Jr., Commanding Officer, was transferred to the 622<sup>nd</sup> BAM Battalion, 27 June 1945, as he had enough points to go home. 1<sup>st</sup> Lt. John T. Lampila, Jr. assumed command the same date. 1<sup>st</sup> Lt. Joseph V. Mazzei was assigned and joined the unit from the 310<sup>th</sup> Ord. Base Armored Vehicle Maintenance Company.

The next move of this unit was from Camp PA, Villacoublay, France to Camp Baltimore, T 647 622 Suippes, France.

At Camp Baltimore the processing of the unit was completed. All records were checked and found in excellent condition. Necessary immunizations were given.

Passes, Leaves and furloughs were plentiful while at Camp Baltimore. Several men were able to return to England to see friends or relatives stationed there. The men of the company were given a well earned rest, even if the monotony of not having anything to do, did begin to get on one's nerves.

The unit's equipment was shipped to Marseilles to be loaded for the Pacific, when the war with Japan ended. Everyone now wondered if we would still go to the Pacific or if we would be fortunate enough to go home or if we would go back to Germany. Rumors flew left and right. One day we were discouraged, the next encouraged.

Then came the news we didn't want to get. The 914<sup>th</sup> Ordnance Heavy Automotive Maintenance Company received orders to move back to Germany.
